Currently, Representative Carter is the Chairperson of the House Health Committee, and a member of the Appropriations Committee as well as a member of the Subcommittee on Appropriations for Education.

Kate Brophy McGee is a third-generation Arizonan who was first elected to the Arizona House of Representatives in 2010 and served three terms. On November 8, 2016, Kate was elected to represent Legislative District 28 in the Arizona Senate. Prior to serving in the House, Kate served for nearly a decade on the Washington Elementary School Board, and was appointed by two Arizona governors to serve on the Arizona School Facilities Board.


