## **Committee Reports**

<u>HCAOA and the Health & Safety Committee:</u> Keffory has received no updates from Krystal; the next chapter meeting will be Wednesday, Feb. 22

**EPDPA/Legislative:** Aaron reported that the minimum wage, based on January cost of living at 6.4% equals a 90 cent increase. His group has a meeting set with new AHCCCS director at the end of March. Aaron is really concerned about not getting things done because the legislature appears to only be playing politics, not focusing on what needs work, and he said another rate increase will be a challenge.

They are working on an approach to a day at the capitol – a popcorn day – because they are essentially starting over with a new legislative group and a new A**Conference**: In Monica's absence, Laurel reported

that the planning was progressing well and that a contact for the new management of the venue had been identified. Linda will contact her next week to confirm details. Lisa also reported that HOV will be a sponsor but didn't yet know at what level. Seth is working on Well Sky to be at conference.

**Education**: Laurel has Tim Rowan of The Rowan Report confirmed as the March speaker and has several others in line for future months..

<u>Communications:</u> Seth reported that the social media group of members has been created but because it's so new, he will have a better idea of the traction on the March call.

<u>Benefits:</u> Steve reported that a letter was being sent to current associates asking what they could/would offer as discounted benefits to AZNHA members. He hopes to have that done by the March meeting. He said his team was in line with the strategic plan deliverables.

<u>Membership Committee for AZ beyond Phoenix:</u> Seth has contacted Visiting Angels in Tucson, along with Margie Lannon of HomeWatch Caregivers in Tucson to talk about what can be done in that area.

<u>New Business:</u> Laurel reported that she's been talking with Dementia Family AZ and Oakwood Creative Care – a non-profit organization that she'd like to bring in as a monthly speaker. She asked the board their thoughts about whether or not the members would be interested in Dementia care as a topic. Everyone appeared to be on board with the idea.
