Committee Reports

HCAOA and the Health & Safety Committee: The AZ Chapter of HCAoA is planning their 2023 conference for May 3 from 9 AM to 3 PM. Admission is \$180 for members and \$360 for non-members.

Conference: Monica reported that they have collected \$15,500 so far and are on track in planning. Most speaker spots have been filled.

Education: Laurel has filled speaker slots through May.

<u>Communications:</u> Seth has created a Facebook group for members only for all and a separate one for Tucson. He's not getting much in the way of response or offers to assist from the Tucson people and said he will give it one more shot; if no further interest, he will more than likely give up trying to develop this group.

<u>Benefits:</u> Ralph said that AZdoes not offer much in the way of benefits in comparison to HCAoA. And HCAoA also does a 'perceived value' to their Zoom calls. He suggested that AZNHA attach a 'perceived value' to the things that we do offer in the way of education, the website listings, etc. The committee is also fine tuning the member benefits list.

<u>Membership Committee for AZ beyond Phoenix:</u> please refer to Seth's comments for the Communications report. Zach will be in Tucson this month and will be investigating interest with members for a So. AZ chapter.

EPDPA/Legislative: Aaron reported that they are starting lobbying sessions. The Popcorn Day is being planned with bags of popcorn with a message and an ask sheet will go to legislators in April. And they are scheduling virtual meetings with new legislators.

He also said they are monitoring the cost of living – January was 6.4% and February was at 6%. They are looking at an 85 cent increase in January with differential pricing. There are two buckets of money – EVV and Pipeline AZ. Aaron is planning to meet with the new director of AHCCCS before too long.
