## **Committee Reports**

**HCAOA:** Keffory reported that the Arizona chapter conference had about 50 attendees – both peer and competitor.

**EPDPA/Legislative:** In Aaron's absence, Keffory reported that they are working on a \$30M increase and a conflict in the statehouse; meaning zero increase in the minimum wage – certainly not as easy as it was for the last few years.

EPDPA leadership has met with the new AHCCCS director who appears to be open to the group.

Grant requests have been submitted and he will know in July if any EPDPA members will be getting any of those funds.

We need to get with legislators to discuss the carve-out for wage increases in 2024.

Stephanie reported on CMS – they are looking at a 90 cent increase. EPA and DVV providers are concerned about the new rules. Personal care, home aid and homemaker services – CMS rule = 80/20 mandates states report that DCWs receive 80% of the rate as wages – meant specific for caregiver pay.

Keffory projected a 70 cent increase for next year.

<u>Conference</u>: Monica reported that Humana and Molina are new sponsors. There are currently 16 tables available. We are short two breakout speakers so there will only be two breakout rooms.

<u>Education</u>: There was a last minute change in presenters for May and Alison of AZ Provider Training stepped up to take the spot. Robert Espinoza will present in June and Pelleton will have July.

**Communications:** Seth has been focusing on conference, so not much being done with this item.

<u>Benefits:</u> Steve talked about the caregiver class and the details of how it will be handled. He also mentioned he has met with Paychex and they have a PEO (Professional Employer's Organization) that is working with associations. Steve is trying to get them to be a conference sponsor and to renew their AZNHA membership.

More discussion occurred regarding potential discounts and Zach mentioned that the Caregiver Education sessions would be viewed as a benefit. Another potential benefit being discussed is with Discount Tire for a 10% discount.

Zach talked about possible on-call mental health help for caregivers.

<u>Membership Committee for AZ beyond Phoenix:</u> Zach reported on his event in Tucson; good turnout and he sent individual messages to all attendees. There was very little interest shown and he said if he could not generate more interest in a Tucson chapter, he wasn't going to take any more time on it.

**New Business:** No new business was brought to the table.

The next meeting will be virtual on Thursday, June 15, from 11:30 AM to 1:00 PM.
